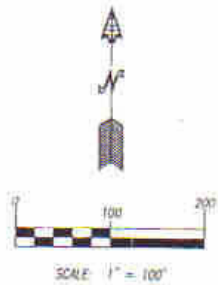


CERTIFICATE OF SURVEY NO. 1746

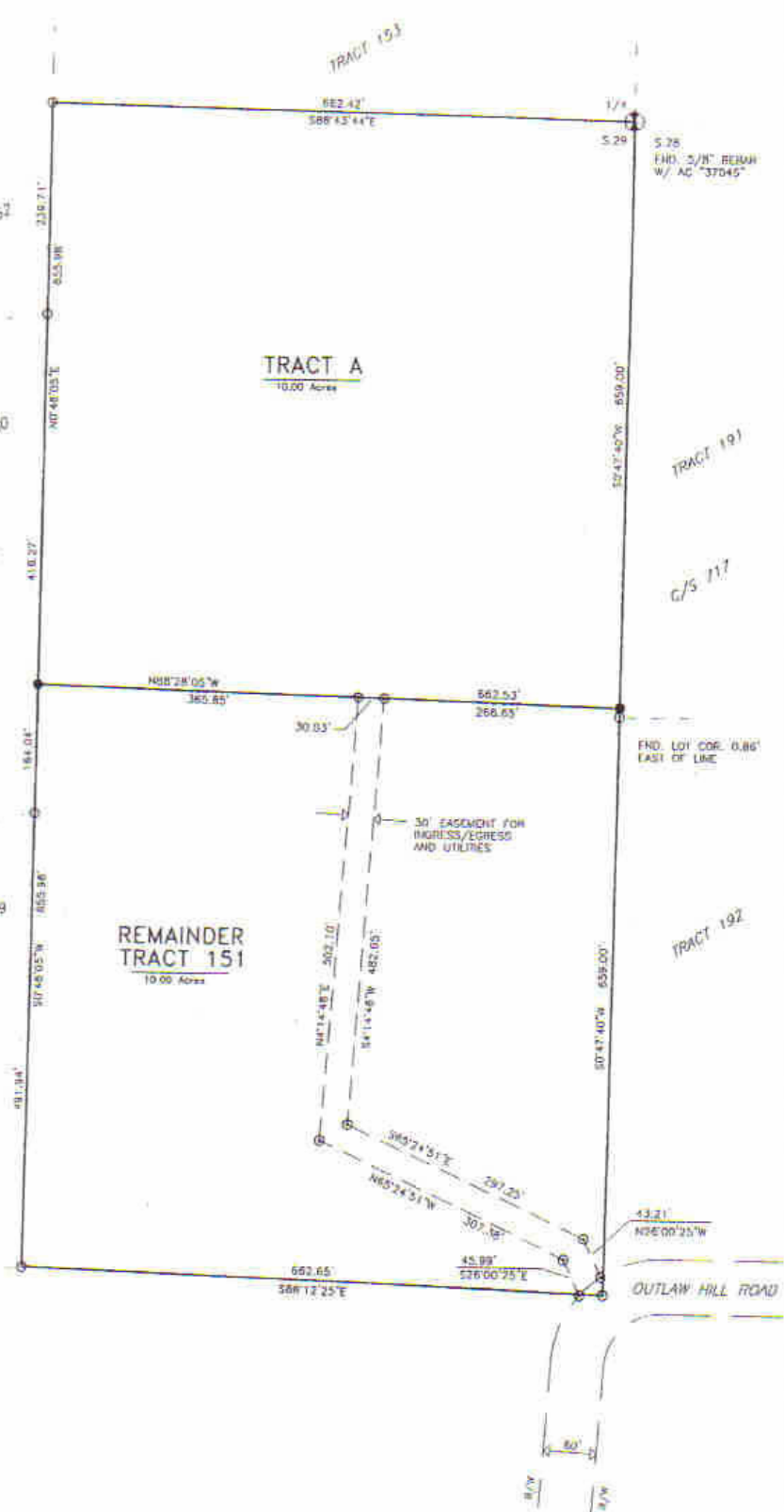
