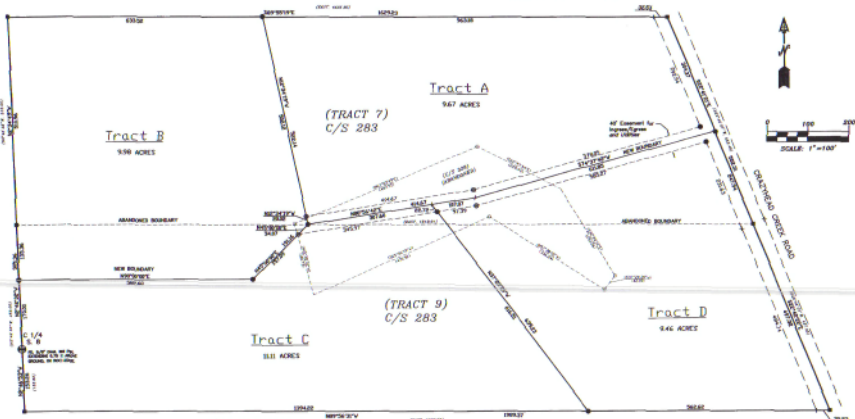
### Book of Settings
